**ACTIVITIES REPORT FOR THE QUARTERLY PERIOD ENDED ON
30TH JUNE 2009**

HIGHLIGHTS:

- **RC Drilling confirms mineralisation in the existing resource shell**
- **Alteration intersected in drilling similar to Gabanintha Gold Mine**
- **100kg bulk sample of outcropping mineralisation submitted for testwork**

GABANINTHA VANADIUM PROJECT, WA (100% YRR):

During the period ended on 30th June 2009, Yellow Rock Resources Ltd (ASX:YRR) carried out a RC drilling campaign on its wholly owned Gabanintha Vanadium Project. The Company has engaged BatteryLimits, a mineral processing consultancy, to examine suitable processing and product streams for the resource. Preliminary metallurgy and chemical studies of drill samples have commenced. A 100kg bulk sample of outcropping massive high grade mineralisation was despatched to Ammtec Pty Ltd for crushing and screening testwork.

The infill drilling campaign was completed with 1233m of RC drilling from 11 holes and the mineralisation intersected will be utilised to upgrade the existing resource. Furthermore, drilling confirmed historical intercepts including the thickest massive zone of 34m of massive magnetite mineralisation in hole GRC155.

An alteration assemblage was intersected in two holes, GRC 156 and 158 and is considered similar to that which hosts the Gabanintha Gold deposit mined by Dominion Mining Ltd, producing over 150,000 ounces of gold at 3.23 g/t between 1987 and 1991. Gold assay results for relevant intercepts are pending.

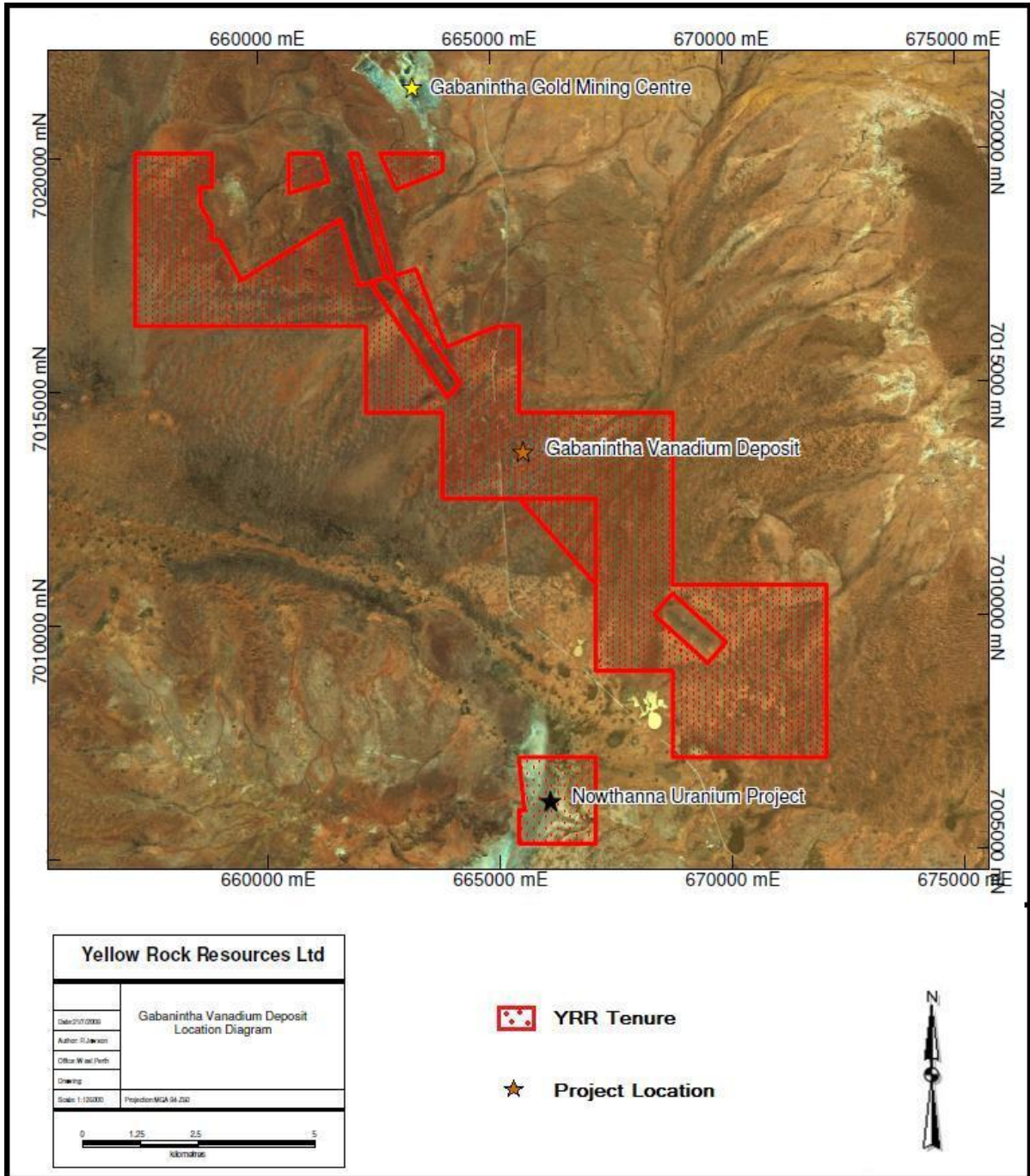
Site preparation for diamond drilling has been completed. The diamond drilling program will occur in the next quarter to provide further definition for bulk density and metallurgical parameters.

NOWTHANNA URANIUM PROJECT, WA (100% YRR):

Yellow Rock Resources has commissioned a desktop review and evaluation of the Nowthanna Uranium lease. Work will include compilation of all historical exploration information and identification of prospective targets.

REGIONAL PROJECTS:

Tenement holdings within Northern Territory and Western Australia have been altered following evaluation of existing projects by means of extensive data compilations and field verification.
